**Membership Commitments**

*(Membership brings certain privileges and obligations that require compliance, including the following.)*

- **Dues/Fees:** There will be no refund of dues paid by the applicant unless applicant is denied membership. I agree that, if accepted for Membership in the Association, I shall pay the fees and dues when due.

New member fees and current year's prorated dues are due at time of application. Starting in September the following year's dues are included.

- **New Member Orientation:** I understand the fee will be returned to me in the event my application is not approved. I understand that I will be automatically signed up for next available classes for both the New Member Orientation and the Code of Ethics classes. In the event my application is approved, *I agree as a condition of membership to complete the indoctrination course (New Member Orientation) of GLAR, within 90 days of membership approval.*
- **Membership Commitment:** I agree that my act of paying dues shall evidence my initial and continuing commitment to abide by the Code of Ethics of the NATIONAL ASSOCIATION OF REALTORS®, Constitutions, Bylaws, Rules and Regulations, of the Greater Lakes Association of REALTORS®, the Minnesota Association of REALTORS®, and the National Association of REALTORS® and duty to arbitrate, all as from time to time amended. I understand that by paying these dues I am granted provisional membership until I am accepted by the Board of Directors. In the event that my application is approved, I agree as a condition of my membership to attend the New Member Orientation and the NAR Code of Ethics class within 90 days of membership approval. If required, I agree to satisfactorily complete the periodic Code of Ethics training. Finally, I consent that and authorize the Association to invite and receive information and comment about me from any member or other person. I agree that any information and comment furnished to the Association by any Member or other person in response to any such invitation shall be conclusively deemed to be privileged and not form the basis of any action by me for slander, libel, or defamation of character.
- Membership is final only upon approval by the Board of Directors and may be revoked should completion of any membership requirement, such as New Member Orientation, not be completed within the timeframe established in the Association's bylaws.
